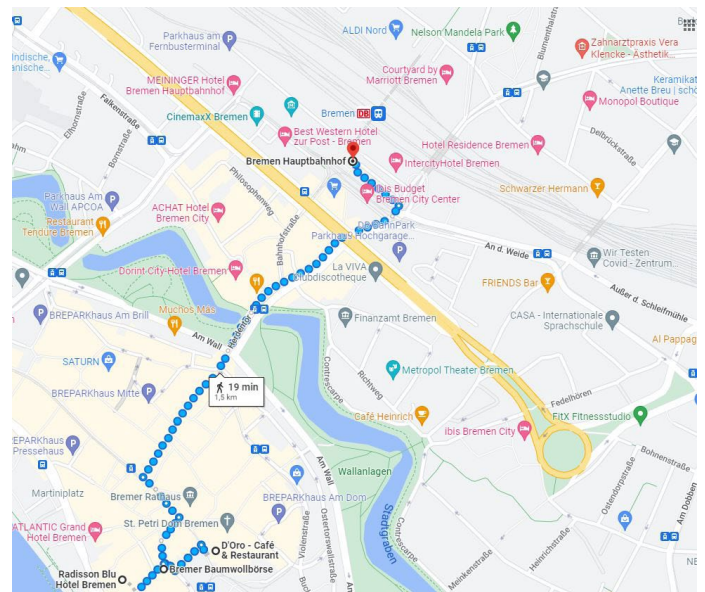

COVID-19 ENTRY RESTRICTIONS:

As of 11 June 2022, all COVID-19 entry restrictions to Germany have been provisionally lifted, meaning that entry to Germany is once again permitted for all legitimate purposes. However, residents of the People's Republic of China still need an essential reason to enter Germany (as a matter of reciprocity); this does not apply to German citizens residing in the People's Republic of China. For entry into Germany, proof of vaccination, proof of convalescence, or proof of testing are no longer required.

For areas with variants of concern, further entry restrictions would apply; however, there are currently no states designated as virus variant areas.

ARRIVAL BY PLANE to Hamburg:

S-1 is the only train line going from Hamburg Airport to Hamburg Central Station. Take line S-1 (towards Blankenese) to Hamburg Central Station (*Hauptbahnhof*), where you can change trains to either a regional train (Metronom RB, 1h 09min, EUR 24) or a long-distance train (IC/ICE, 55min, EUR 44).

Tickets can be booked online or purchased directly at ticket machines in railway stations.

The distance to Bremen is approximately 120 kilometres, which takes about two hours. Therefore, we do NOT recommend taking a taxi.

ARRIVAL BY PLANE to Bremen:

There is a regular tram connection from Bremen Airport to the conference hotel, Radisson Blu. Take tram line 6 towards University Station (*Universität*); the tram stop is directly in front of the arrival terminal. Exit at the “Domsheide” stop. Walk along “Marktstrasse” for 200 metres, staying on this street as it makes a left turn and changes names to “Wachtstrasse”. The hotel will be on the right.

A taxi ride from Bremen Airport might take 15 minutes and cost approximately EUR 15.

ARRIVAL BY TRAIN to Bremen:

Directly in front of the station, take tram line 4 (towards Arsten) or tram line 6 (heading towards the airport, i.e. *Flughafen*). Exit at the “Domsheide” stop and walk 200 metres to the Radisson Blu Hotel.
